No labor cost or other expense or liability will be assumed.

The Uniform Commercial Code shall not apply to this sale, nor the Texas statutes adopting the Uniform Commercial Code.

This express warranty is in lieu of and excludes all other warranties, guarantees, or representations, express or implied. There are no implied warranties of merchantability or of fitness for a particular purpose.

PURCHASER'S REMEDIES

The Purchaser remedies with respect to any product furnished by Boltex Mfg. thereunder that is found not to be in conformity with the terms and conditions of the contract because of breach of contract, breach of express or implied warranty, or negligence shall be limited exclusively to the right of replacement of such defective product or, at our option, repayment of our sale price of the product. In no event shall Boltex Mfg. be liable for claims(based upon breach of contract, breach of express or implied warranty, or negligence) for any other damages, whether direct, immediate, foreseeable, consequential, special or for any expenses incurred by reason of the use or misuse, sale or fabrication of products which do or do not conform to the terms and conditions of the contract.

PRICES

ACCEPTANCE OR ORDERS

All orders are subject to Boltex Mfg. credit department approval prior to acceptance by Boltex Mfg. No assignment of the Purchaser's rights may be made without the written consent of Boltex Mfg.

REMITTANCES

All accounts are payable in the United States funds, free of exchange, collection, or any other charges. If in the sole discretion of Boltex Mfg., the financial condition of the Purchaser at any time so requires, Boltex Mfg. retains the right to require full or partial payment in advance.

TAXES

Unless otherwise specifically noted the amount of any sales, use occupancy, excise tax, or other tax, of any nature, federal, state or local for which Boltex Mfg. is legally liable, either initially or through failure of payment by Purchaser, shall be added or invoiced in addition to the price quoted and the Purchaser agrees to pay the same to Boltex Mfg.

SHORTAGES AND DAMAGES IN TRANSIT

Claims for shortages must be made in writing within ten (10) days after receipt of shipment, but loss of or damage to materials in transit is the responsibility of the carrier.

DELAYS

All promises of shipment are estimated as closely as possible, we will use our best efforts to ship the time promises but do not guarantee to do so and assume no liability for not doing so. Materials stated to be in stock are subject to prior sale.

CANCELLATION AND SUSPENSION

The order or contract is subject to cancellation or instructions to suspend or delay work or delivery only upon receipt of written notification and with our consent and upon agreement to pay Boltex Mfg. adjustment charge. Order for special products (usually "price application" items) mat be changes or canceled only upon written instructions with a tacit understanding and agreement to make payment for material used and work already performed.

RETURN OF MATERIAL

No product of our manufacture may be returned without written consent. All goods are subject to a handling charge, freight in both directions and charges for any required reconditioning unless otherwise specified in writing by Boltex Mfg.

PATENTS
